- Chair Dan O'Malley Strategic Plan based on 4 Cs as a member of the NVOAD
 - o Have reached out to a consultant with MSU for strategic planning
 - Goal be done by Sept meeting for approval by annual meeting in October
- Vice Chair Chelli Ringstaff
 - No report
- Secretary Laura Croff MSP Approve meeting notes,
 - FEMA Individual Assistance revision updates:
 - IA is the FEMA program that includes direct dollars to survivors for repairs, displaced housing assistance, replacement of lost food in your fridge from loss of power, and several other things...This program is being updated in many ways like the application process, to deadlines for assistance, appeal processes, etc.
 - There was a webinar for VOAD folks last week and there will be more meetings moving forward during the "public response" period over the next month – these are regulation changes and not changes to the law, so they are easier to put into effect – the start of the changes is March 22 – it will NOT be retroactive
 - Some highlights include:
 - Survivor doesn't have to apply/be denied for SBA before being eligible
 - Other Needs Awards is an automatic with any IA declaration (previously, we had to apply separately)
 - Application for housing assistance money has been simplified and given a "grace period" to allow for folks to find some where to go – the "recertification" process has been made easier

- Appeal letters have been eliminated there will be a form for appeal now documentation will still be required, but may not need to be as extensive
- Late applicants won't need the same ridiculous amounts of documentation
- There is some adjustment regarding "pre-existing" damage if the issue effects habitability, it may be eligible for FEMA
- Accessibility items don't have to be "pre-existing" to be eligible for FEMA funding
- Self-employed (gig) survivors can apply for funds to help get their businesses back on track
- Treasurer Chad Veeser
 - Not much to report since last month still waiting for response from State of Michigan
 - o Bank just needs approval from the federal side to move forward
 - Formal budget will be presented to the group
 - Will be using MSP/EMHSD as a permanent address until other physical mailing options are available
